This will confirm the results of the case management video conference held on  
April 8, 2021. The following summarizes the case management outcome:

- a) The Board heard submissions concerning the Staff Association's request for an interim production order, and submissions from the Faculty Association and Board of Governors that the application is broad and insufficiently particularized. The Board reserved its decision on those points and the next litigation steps to be ordered, pending the results of a resolution conference between the parties. The Board directs a resolution conference be held forthwith to determine whether agreement can be reached between the parties on: (1) a process to consider the determination issues between the parties without litigation; (2) the potential focusing of this application and/or the production requests.
- b) Following that resolution conference, the Board will issue such directions as may remain necessary stemming from this teleconference for next steps on these files.
